

## PLEASE FOLLOW ALL THE INSTRUCTIONS BELOW WHEN REQUESTING AN ELECTRONIC FBI BACKGROUND CHECK

- 1. Go to https://www.edo.cjis.gov
- 2. Scroll down to section header "How to Submit A Request". Enter your e-mail address in the blue box (right side) and click "Submit".
- 3. With the email provided, you will receive an email from the Criminal Justice Information Services. Click "here" to access your request.
- 4. Click "continue" after reading the passage regarding 28 CFR 16.30-16.34
- 5. Enter PIN and click "Login". Your PIN can be found in the first email.
- 6. Section 1: Applicant Information
  - Fill out all boxes marked in red
  - You will also need to provide the last four digits of your SSN
  - Reason for Request: Personal Review

## 7. Section 2: Mailing Address

- You will need to provide the mailing address for Child Care Aware® of America:

- 8. Section 3: Preferences
  - a. Would you like your date of birth included on your response?
    - i. Yes
  - b. Would you like to receive status notification?
    - i. This is up to you. We strongly encourage individuals to state "yes".
  - c. Would you like to have a hard-copy response mailed to you?
    - i. Yes
- 9. Section 4: Fingerprint Card
  - a. Please send your completed fingerprint card along with a copy of your confirmation e-mail to:

## 10. Section6: Review

- a. Verify that information is correct and click "yes"
- b. Notice will appear "You will now be redirected to Pay.gov to process your payment." Click "ok"
- 11. Select payment method and enter in payment information
  - a. Make sure to save documentation showing that you have paid and submitted your application for processing. This information will be needed to provide extensions and/or grant reimbursement.
- 12. Application is submitted and payment made\*:
  - a. You will now need to go get fingerprinted. To find a fingerprinting location in your area, please visit: <a href="http://myfbireport.com/locations/index.php">http://myfbireport.com/locations/index.php</a>.
    Fingerprints should be placed on a standard fingerprint form (FD-258) commonly used for applicant or law enforcement purposes (see attached blank form). Once the FBI receives your fingerprint card they will process your background check request.

<sup>\*</sup>Your submission will not be processed until after the Federal Bureau of Investigation (FBI) receives your fingerprint card. You will need to send the fingerprint card **and** your confirmation email to the mailing address in Section 4.
