A note from:

2020 marked a watershed year for child care in the United States. As a nation we experienced overwhelming loss and devastation in our communities, and the experience was incredibly personal. But in the face of a deadly pandemic, the child care community rose to the occasion, demonstrating tremendous resilience, innovation, sacrifice, determination and compassion. The heroism of early care and education providers, parents and Child Care Resource and Referral Agencies (CCR&Rs) made it possible for first responders and essential employees to continue to do their vital work knowing that their children were safe and well cared for.

Child Care Aware® of America shifted quickly to providing a wealth of information and resources to the child care community, details of which are included in this report. By providing business supports, technical assistance, reports on funding streams available from the federal government and other sources, we helped the child care community make difficult decisions about staying open and following the latest health and safety guidelines. We also worked for months with our network of grassroots advocates and our allies to fight for federal relief for child care.

The disparities in the impact of the pandemic among communities were painfully obvious, with communities of color and women in the workforce bearing the brunt of the challenges. The increased attention during 2020 to racial justice and equity issues spurred reflections on the way that racism has manifested in the child care system historically and to this day. We integrated diversity, equity and inclusion goals in our work internally and externally. We conceived and led "Together Toward Transformation," a comprehensive effort to gather input from across the early childhood education community to envision child care in a new, better, more equitable way. We infused diversity and equity content and direction in all our trainings, resources and technical assistance. We also made it the focus of our advocacy efforts, raising awareness of disparities.

Our efforts to re-envision child care continue. Child care was essential long before the pandemic, but 2020 highlighted just how valuable it is for families and for the economy. For decades, child care has been underfunded and plagued by disparities and inequities. The pandemic shined a bright light on those shortcomings, and the critical need to address them for the good of the child care community, families and children, and the country as a whole. "No Child Care, No Recovery."

Words cannot express how deeply I appreciate all the child care providers, CCR&Rs, and CCAoA's remarkable staff who rose to the occasion to support children and families over the past year.

Our commitment is stronger than ever to ensuring every child and family in the United States has the opportunity, tools and resources to thrive, and we believe that child care programs are critical for achieving this goal. This past year has necessitated serious reflection on our history and our future as a field. What is our charge moving forward? What will transformation really look like and how will we hold ourselves accountable for the audaciously bold goals we have set for ourselves for the coming year?

I invite you to review the highlights of our work during a year that presented so many challenges as well as opportunities. Thank you for your support.

Strategic Plan

Our 2020-2022 Strategic Plan and metrics were informed by the Child Care Aware® of America Board of Directors and the hard work of the Strategic Oversight Committee. The process involved interviews with numerous stakeholders, including staff, national partner organizations, CCR&Rs, foundations, the business community, parents and the child care workforce. We are grateful for the leadership of that committee and its co-chairs, Paula Neth and Tonja Rucker. Together we made a commitment to use metrics to inform our progress and plan for what's ahead.

Our current Strategic Plan was launched in January 2020, and shortly thereafter the COVID-19 pandemic struck. In spite of that, it became apparent that our strategic plan would hold strong. In fact, we saw an acceleration toward achieving our targets.

In 2020, guided by a commitment to be equity-driven, childcentered, family-engaged and communityfocused, CCAoA led the charge to support and transform child care by:

- Advancing state and federal policy
- Expanding comprehensive child care services available to children and families
- Supporting and re-envisioning the child care system and infrastructure
- Strengthening a healthy, equitable and thriving organization

COVID-19 Response and Recovery

In March 2020, CCAoA responded swiftly to the virus and became an all-remote workplace. Staff worked tirelessly to provide needed resources and support to CCR&Rs, providers and families.

COVID Response

From March 11 - December 2020, we developed:

- Suites of <u>COVID-related resources</u> targeted to child care professionals, policymakers and families.
- 23 webinars with a total of 57,305 participants.
- A <u>Story Hub</u> with video and audio stories about individual providers and families coping with COVID-19.

We launched the <u>Emergency Child Care & Technical Assistance Center</u>™ to support the child care community during the pandemic. It greatly expanded CCAoA's capacity to respond to COVID-19.

• We provided direct technical assistance and consumer education to 5,358 CCR&Rs, child care providers and parents.

CCAoA created the executive summary and worked with an external media team to promote the findings in October 2020.

Picking Up the Pieces: Building a Better Child Care System Post COVID-19

On September 24, CCAoA launched its massive <u>Picking Up the Pieces report</u> that combined data on child care through the <u>Child Care Data Center</u> and the impact of COVID-19.

- Media coverage in the first 24 hours after the release of our report reached an estimated online audience of over 120 million, including a MarketWatch story reposted on Yahoo Finance and a CNBC.com story reposted on MSN Money.
- Within the first month, the report site had been viewed more than **10,000 times**.
- One of the infographics was shared by CNBC and had an additional **6,000 views**.
- In 2020, more **than 2,200 people** accessed the Child Care Data Center

What about a national average price of child care?

Every year, CCAoA calculates the affordability of child care in each state. We are often asked for a national price of child care, which we present here – with reservations. The child care landscape varies widely from state to state, and those distinctive differences are lost when you try to calculate a national figure.

FALL 2020

The national average is between \$9,200 and 9,600 per year.

And that cost grows for families with multiple children in care.

With that caveat in mind, we determined that the national average price of child care for one child is between $\$_{9,200}$ and $\$_{9,600}$ a year. That represents more than 10% of household income for a married couple and $\imath_{4\%}$ of household income for a single parent.

Since the Start of the Pandemic

Many providers report that COVID-19 is having a direct and profound effect on the cost of doing business.

Everything that we do now costs more. Our food costs have gone up, delivery charges have increased, our overhead expenses have gone up, our insurance - we got a notification the other day that our insurance on the property is going up. So everything that it takes to operate the business has increased in response to the virus.



Media Tour: Lynette M. Fraga, Ph.D.

The COVID-19 pandemic highlighted how essential child care is for working parents and for the economy, which led to increased interest from policymakers and the media. We leveraged this opportunity to advance our strategic goals by working with an agency to arrange a Satellite (TV) and Radio Media Tour for our CEO, Lynette M. Fraga, Ph.D.

Dr. Fraga participated in 32 interviews (15 television and 17 radio) as part of the Media Tour from April 2-7, 2020.

The interviews generated a total of **2.4 million viewer and listener impressions**,

Three TV interviews were with **national TV groups: Scripps TV, Nexstar TV and Cox Television Group**. One interview was with a statewide TV network, Spectrum News Ohio, and the remaining 11 interviews were with local TV stations.

The national TV interviews aired in all states and the local TV interviews aired in 14 states and the District of Columbia.

Of the 17 radio interviews, three aired live and 14 interviews were taped. The interviews reached **45 radio outlets with a combined audience estimate of over 680,000.**

Quality Child Care: An Investment in our Children and their Future

Quality care provides the emotional and academic support children need to be school-ready by the time they enter kindergarten. Research shows that children who attend highquality early childhood programs have more positive long-term outcomes, including higher rates of graduation from high school, higher income, better physical health and stronger families. The outcomes also benefit the country as a whole, because they're associated with lower crime rates, a stronger economy and healthier communities.

To support this work, CCAoA:


- Developed a revised set of child care licensing standard benchmarks, a scoring rubric and a shareable state snapshot resource: the <u>Child Care Licensing Benchmark Project</u>. In the first month after launch, more than **3400 contacts** viewed the Project and **44 people from 21 states** requested more information on how to join.
- Updated and promoted a series of <u>consumer education</u> <u>brochures</u> explaining quality child care. These resources have been **viewed more than 11,000 times in 2020**.
